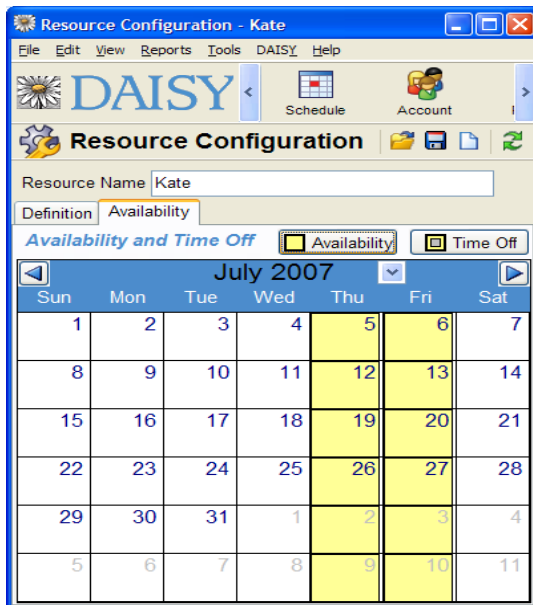

Need a vacation? Here's how to easily mark time off for your practice.

When you need to mark time off for a resource in your office, here is an easy way to do this.

1. From the DAISY menu, select Appointment, then Configure, then Resources.
2. Search for and select the resource, then click OK.
3. Click the Availability tab of the Resource Configuration window.
4. Right click on the day you want to close and select New Time Off
5. In the Reason text box, type a name for the closed day, then select a Type. Last, select the All Day button.
6. Set the date to be closed in the Effective Dates Beginning and Ending box.
7. Close and Save the window by clicking the red X in the top right Corner



Hint: If you are closing the day for more than one resource, make these edits to the Appointment / Practice window instead of the Resource window. When you save your time off settings, you will be able to select the Resources who are affected by the setting.

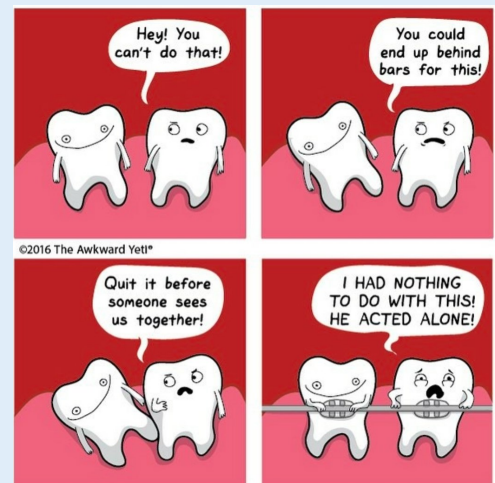
