Do you have patients with benefits remaining?

Are your patients aware of what their annual maximum is? Insurance plans offer an annual benefit amount for patients to obtain necessary dental treatment within their calendar or benefit year. Using DAISY reports, you can get a list of all patients with benefits remaining. For example, let's say you want to know all the patients with \$100 or more in benefits remaining. Here's how:

- 1. Open the Report Gallery and open the Claims/Insurance folder.
- 2. Right-click on Insurance Coverages and click Properties
- 3. Click Reset
- 4. Click the **Benefits Remaining** tab
- 5. Change your search parameters by changing the **any value** to **greater than**
- 6. Type in 100 and click OK
- 7. Double-click on the **Insurance Coverages** report to open and view the list of patients
- 8. You can now print or archive this report

Are you expecting a DAISY update? Leave your computers powered on!

As a reminder, the DMC auto update process will install the DAISY update at approximately midnight on your scheduled date. Below are some considerations regarding the auto update process.

Do not power off your DAISY server and workstation(s) on your scheduled date.

Save all work and exit DAISY windows on your scheduled date.

If you power off overnight, your system will perform the update once it's powered on. This process could take up to **one hour**, impacting your morning routine. If you restart during the update process, this will start the update process over again. You will not be able to use DAISY during the server installation.
