## CDT 2016 procedure codes

CDT 2016 codes will be distributed through DAISY Auto Updates on December 31, 2015 and no installation is necessary. In order to receive the CDT 2016 procedure codes, your server will need to be powered on. If you will be out of the office on December 31, the CDT 2016 procedure codes will update once you return to the office. There are some codes that no longer exist in the CDT 2016 code set, even though you may already have those codes attached to appointment templates, treatment plans and chart buttons. These codes will need to be manually removed and/or replaced with a valid code on a case by case basis. Please refer to the CDT 2016 book published by the ADA for code revisions.

## Calendar year benefit renewal process

Insurance plans run on either a benefit or calendar year. For insurance plans that are scheduled for a calendar year benefit renewal, please note that the annual maximum benefit will update once you run a daily closing in 2016. For example, if your office takes holiday vacation at the end of 2015 and your first day back in the office is on Monday, January 4, 2016 you will need to run a daily closing on January 4, 2016 for the annual maximum benefits to renew. This is the way DAISY recognizes it's now 2016 and time for the calendar year benefits to renew.

## Thinking about end of year?

The end of the year is rapidly approaching so we are taking this opportunity to provide information about end of year tasks within your DAISY system.

Closing out for the year simply means getting all appropriate transactions and other data entered/posted before the year has ended, then running some reports after the year has ended.

DAISY offers the ability to run reports for the entire year's activity to meet your needs for closing out for the year. Individual reporting needs will vary from office to office, but they generally include transaction-based reports filtered for prior calendar year.
